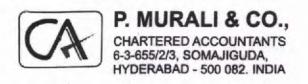

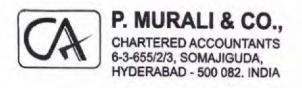
In our opinion and to the best of our information and according to the explanations given to us these Quaterly financial results as well as year to date results:

Emphasis of Matter:

 The Company has been incurring losses continuously which has resulted in complete erosion of Net Worth. However, the management still believes that Going Concern of the company is not affected for the reasons detailed in note no.27 of annual Financial Statements and accordingly prepared financials as at 31st March 2023 on a going concern basis.

 The company is irregular in payment of statutory dues like PF, ESI, TDS, GST and PT etc., The Outstanding Statutory dues up to the Quarter ended 31-03-2023 is Rs.2.09 Crores.

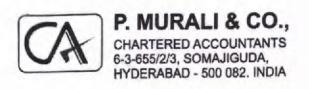
Our Opinion is not modified in respect of the above Emphasis of Matter.

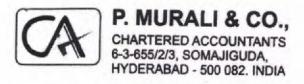
